

# MEMBERSHIP INFORMATION – RULES & REGULATIONS

1. Membership Year – The Membership Year is from date of joining or renewal for a 12 month period.
2. All rights and privileges will be withdrawn if no payment or indication of payment is made within 7 days from the day the payment is due.
3. Cancellation of Membership is subject to the refund policy stated below

4. Any member who wishes to pay the membership in installments, he/she will be required to either fill out a Credit Card Authorization Form or submit Post Dated Cheques dated as relates to their Membership payment terms.
5. Rejoining Fees – There is a 1000 AED fee for members who rejoin the club during the membership year.
6. Single and Family Memberships are Non-Transferable.
7. Junior Golfer – A Junior Golfer is one who is under 16 on 1<sup>st</sup> February of the Membership Year.
8. EGF Fees – All membership fees must be paid along with EGF fees (400 AED per adult – over 18 years of age, 50 Dhs – per Junior under 18. These are collected by Tower Links Golf Club on behalf of the EGF Golf Federation. EGF Fees cannot be pro rated. Payment of this fee is not applicable if already paid to any other EGF Affiliated Golf Club.
9. Members Discounts – All Members are entitled to Members discounts, which may vary from time to time and according to season. A minimum 10% members discount is applicable to all F&B and Pro Shop purchases.
10. Tee Time Booking Privileges:  
 Gold & Country Members receive a 10 day booking privilege.  
 Silver Members receive an 8 day booking privilege.  
 The Reservation Desk is open for bookings daily, call direct number +971 7 227 9939 or +971 7 2278555.
11. Members are requested to check-in at the Reservation Desk prior to play.
12. Members can avail bag storage and lockers facilities at annual fees of AED 350 and AED 250 respectively.

13. Access to Golf Course – To gain access to the Tower Links Golf Club golfers must have a recognized Golf Handicap or a Playing Certificate Card – (The Playing Certificate Test can be taken as part of a course of introduction lessons or individually with one of the Golf Professionals as a 30-minute test. For further information contact the Golf Office.
14. Dress Regulations – Access to the Golf Course requires appropriate golfing attire including collared shirts and no blue denim jeans. The Driving Range dress regulations are more relaxed – but must still be appropriate.
15. **Cart Policy Waiver:** I hereby release the golf club from any and all civil and/or criminal liability that may result from my operation of this vehicle. I also agree to be responsible for any damage caused to such vehicle or property of the club or third party.
16. A maximum of two (2) carts with a maximum of two (2) persons are allowed per group unless approved by the management.
17. At any time players may be paired up to make a four ball.
18. The club is not liable for any injury sustained by players during playing.
19. Tower Links Golf Club is not responsible for any loss or damage to personal belongings on the club premises.
20. Informing the Reservation Desk of cancelled tee time bookings is not only courtesy but also a requirement. Repeat offenders who do not inform the club a minimum of 48 hours prior to their tee off may have their booking privileges suspended.
21. The Management reserves the right to cancel the memberships in case of any unforeseen circumstances which may arise during the membership period by giving one (1) month notice to the members and all monies will be refunded on a pro-rata basis (excluding EGF).
22. Management Waiver- The management of Tower Links Golf Club reserves the right to amend the above terms and conditions.
